11 **RESCINDING GENERAL ORDER 20-05 AND REQUIREMENTS**  
12 **FOR APPEARANCES IN THE CALAVERAS COUNTY**  
13 **SUPERIOR COURT IN RESPONSE TO COVID 19**

14 WHEREAS, IT IS THE MISSION OF THE Calaveras County Superior Court to  
15 provide equal justice for all, and

16 WHEREAS, the Court's values are to provide equal justice in a timely, consistent  
17 and professional manner,

18 WHEREAS, the Superior Court of Calaveras County (Court) continues to closely  
19 monitor the Novel Coronavirus (COVID-19) situation. The Court is applying guidance  
20 from the Federal Centers for Disease Control and Prevention (CDC), California  
21 Department of Public Health, Calaveras County Health and Human Services Agency, and  
22 the Judicial Council of California to mitigate the impacts of the COVID-19. The Court is  
23 assessing its response to the crisis as new information becomes available. Any  
24 modifications to Court operations will take into consideration the health and safety of the  
25 public, justice system partners, and employees, while protecting liberty and due process  
rights.


26 NOW, EFFECTIVE IMMEDIATELY, IT IS ORDERED as follows:

- 27 - **General Order 20-05:** General Order 20-05 restricting courthouse entry and  
28 permitting access only to those persons required to appear in person at the  
29 Calaveras County Superior Courthouse is rescinded.
- 30 - **Facial coverings:** While inside the Calaveras Superior Courthouse, the public  
31 is required to wear face coverings.

- **Court calendars:** All parties are to remain outside the courtroom until their matter is called. Subject to judicial discretion, one case is to be called at a time. Any member of the general public who has an interest in a case, may enter the courtroom when that case is called.

- The above modifications will remain in place until further notice.
